## GENERAL CONDITIONS

**LOCATION:** The sale will be held on the Car Park Field, Usk Showground, Gwernesney, Usk, Monmouthshire, NP15 1EY

**SALE ORDER:** Commencing 11am - Flock Ewes; Yearling Ewes; Store & Ewe Lambs; Breeding Rams.

Vendors from 2019 Sales will be divided into three blocks based on last year's catalogue order of sale and will be rotated year on year. New Vendors for 2020 will be lotted at the beginning or end of each section.

**WASH FACILITIES:** Facilities will be available on site to cleanse and disinfect lorries and trailers delivering sheep to the sale.

**CONDITIONS OF SALE:** The sale is held subject to the Livestock Auctioneers Associates Condition of Sale (available at the Office) and at the back of the catalogue.

**SHEEP IDENTIFICATION:** The sale is registered as a 'Central Point Recording Centre (CPRC)' by the Welsh Assembly Government/DEFRA. Vendors bringing sheep to the sale can place a tick against the CPRC Box on the AML1 Licence. The auctioneers will provide a list of the electronic ear tags which have been read. **There is no requirement for vendors of breeding sheep with full EID to read tags prior to the sale.**

All Breeding Sheep **MUST** have Full EID.

All Store Lambs intended for slaughter **MUST** have an Electronic Tag or Full EID.

**Non Electronic Tags are no longer permitted.**

Williams Associates shall not be liable in any way for deficiencies in the recording of EID Tags. Williams Associates and its Staff shall endeavour to read all electronic tags and provide a list to Vendors and Purchasers. No responsibility for the accuracy of information is given or implied. Williams Associates will not be responsible for reading or recording Manual Tags.

**COMMISSION:** All sheep at 3.5% + VAT except for Breeding Males at 5% + VAT.

**N.B.** All Breeding Rams or Ram Lambs shall incur a £5 plus VAT per head entry fee. The entry fee shall only be retained for Rams or Ram Lambs not presented for sale.
