DESCRIPTION

Situated in the quiet and scenic village of Gwehelog, an exciting opportunity to acquire approximately 0.19 acres of amenity woodland. With road frontage, the land has been unmanaged in recent years, however has the potential for recreational use or environmental enhancement (STPP).

NOTE: A public footpath runs along the southern boundary of the land.

Freehold with vacant possession upon completion.
